Change in by-laws require approval of members

We previously announced that the Santa Anita A's Board approved a plan to change the club's operating year from a Fiscal year, running from June 1 through May 31, to a calendar year running from January 1 through December 31. This change requires a revision of the club's by-laws which governs our operating procedures. At their December 10th meeting the board agreed on the proposed changes in wording. These by-law changes must be approved by the club membership.

Our current by-laws state in **Articles IX, Section 1 Amendments:** "These by-laws may be amended or repealed and new by-laws may be adopted by a two-thirds vote of members at any meeting. The proposed changes must be submitted in writing to the membership at least five (5) days prior to the meeting."

The proposed revised by-laws will be mailed to all members in mid January 2015 for their review. A vote for approval of the by law-changes will take place at the January general meeting.

The only changes being made in the by-law wording (other than correcting a few typos) are to the dates affecting our operating calendar which include:

Operating calendar	Current	Revised
Establish Nominating Committee	February	September
Announce Committee members	February	September
Announce slate at meeting	March	October
Dues due for following year	April 1	January 1
Election of Officers and Board	April	November
Start of operating year	June 1	January 1

New members joining our club starting in January 2015 will pay dues for the full calendar year 2015. Current members will be invoiced in March of 2015 (due April 1) for dues covering the balance of 2015, prorated for the remaining 9 months (2/3 of regular dues).

A complete copy of the current by-laws with the proposed changes noted, will be mailed to you around January 12, 2015. A copy of the proposed by-law changes can also be viewed on our web site in the members only section. These changes will be effective January 1, 2015, upon approval of the changes at the January meeting.

At our General meeting on January 30 members will be asked to vote on approving these by-law changes. A two-thirds vote is required for passage.

On Sept. 21, 1897, The New York Sun published what was to become the most widely read letter to a newspaper. It was sent by 8-year-old Virginia O'Hanlon, who lived with her parents in Manhattan. Below is the full text of that letter and the reply by Sun editorial writer Francis Pharcellus Church.

Yes, Virginia, there is a Santa Claus

Dear Editor, I am 8 years old. Some of my little friends say there is no <u>Santa Claus</u>. Papa says, "If you see it in The Sun, it's so." Please tell me the truth, is there a Santa Claus? Virginia O'Hanlon 115 W. 95th St.

Virginia, your little friends are wrong. They have been affected by the skepticism of a skeptical age. They do not believe except they see. They think that nothing can be which is not comprehensible by their little minds. All minds, Virginia, whether they be



men's or children's, are little. In this great universe of ours man is a mere insect, an ant, in his intellect, as compared with the boundless world about him, as measured by the intelligence capable of grasping the whole truth and knowledge.

Yes, Virginia, there is a Santa Claus. He exists as certainly as love and generosity and devotion exist, and you know that they abound and give to your life its highest beauty and joy. Alas! How dreary would be the world if there were no Santa Claus! It would be as dreary as if there were no Virginias. There would be no childlike faith then, no poetry, no romance to make tolerable this existence. We should have no enjoyment, except in sense and sight. The eternal light with which childhood fills the world would be extinguished.

FROM THE SHOP BENCH by Bob Travis

The following article appeared in the April 2010 issue of the Milepost (Newsletter of the Model A Touring



Club). It is reprinted here with the intention of being helpful to our new members and as a reminder to our more experienced members. Club members acting as tour directors should be knowledgeable of these "rules of the road".

Touring Sense

Most of you should know the "Rules of the Road for Model A Touring," but some may not be cognizant of all of them and then there are those who have forgotten some. Therefore, let us put forth some rules, that will make touring safe and sane for Model A's and modern cars that share the road. We assume at the start that everyone in the group has radio communications.

- 1. <u>Never travel in groups of more than five cars.</u> California law defines more than five cars traveling in a group as a "Convoy," which requires a permit. Some of us have been stopped for violating this law. All states may not look at us in this way, but it makes sense to keep the groups small. Each group leader should have the tour route directions so that there is no need for keeping the groups ahead in sight.
- 2. When traveling in a group on freeways or four lane highways, allow approximately 1000 feet (three football fields) between cars. This will allow modern cars, even big rig trucks, to pass. Stay in the Number-One (slow) lane unless you see that this lane exits before you want to do so. If the leader is not in the Number-One lane, then follow him or her. The leader should warn the group when changing lanes. Upon notification of a lane change, cars behind the leader may initiate the change as soon as the next lane is clear and notify cars ahead that you have "Closed the back Door." Upon entering urban areas on surface roads and streets with traffic signals, you should close up the separation distance commensurate with the speed of traffic flow. Keep enough room to safely brake, but not so much as to invite moderns to cut in. Be alert approaching traffic signals to facilitate the group getting through on the same green light. Don't dawdle! Drivers lagging behind is generally the cause of splitting the group. The leader should never accelerate to "beat" the light. He will cause a definite split and will have to wait anyway.
- 3. Be alert to traffic behind you. "Tail-End Charlie" car must be alert for modern traffic build up and notify the lead car to look for the first opportunity to pull over, allowing modem traffic to pass the group. The leader must exercise good judgment and if he feels there is little likelihood of group pull-outs, in the next few miles, he should inform the group to make way for modern cars individually. The next car should take the same action, allowing the modern car traffic to pass him. If this is the case, the leader must pull over at the first opportunity to reform the group.
- 4. If a car breaks down, only the Model A following should pull over to assist, all others should keep moving. The driver of the broken car should notify others in the group by radio that he has stopped. If there is a designated "mechanic" in the group, he should be notified and come to assist. Good judgment is required by drivers

of "lame" cars when using the Interstates. Try to avoid pulling over on the shoulder of a busy highway. If the car can limp along pull off at the next off ramp. Advise the leader well in advance so that the group can exit together.

5. If there is a modern car traveling with a group of Model A's. it should not follow *immediately behind the* group of A's unless it has a sign advising following traffic that "Antique Cars Ahead." Otherwise, drivers of modern cars approaching the group from behind will not realize that the modern car following the Model A's is part of the group and will hesitate passing him, expecting him to pass the Model A's first.

The rules for groups without radio contact are much the same; however, group control is much more difficult and therefore, radios are encouraged, at least in the lead and Tail-End Charlie cars. Here are some exceptions:

A. With no radio, each driver must take responsibility for the car immediately behind him or her. We'll call this the "car behind." When driving on an Interstate, the gap should be closed up to try to keep the car behind in view. If a modern and especially a truck fills the gap behind you and you aren't approaching an exit where the rear traffic is likely to exit, slow down perceptively. Hopefully, this will cause the intervening driver to pass or at least move to the next lane giving you a clear view behind.

- B. On two-lane roads, each driver must make way for a back up of modern cars on his or her own. Do what the behind car does!
- C. The leader must make frequent checks to see that the group is together and must stop if ever in doubt to allow a regrouping.
- D. At all turns that might not be obvious (Blind Turn), a driver will not make the turn until such time that the car behind is clearly in sight and that driver probably has the car ahead in sight. This may require the driver about to turn to park beside the road until the car in the rear comes into view.
- E. After completing a "blind turn" described in D, proceed straight ahead until you see the car ahead of you. The driver is obligated to wait until you can see where he or she is going.
- F. If the car behind pulls over for any reason, the car ahead should do so, as well. This sends a signal up the line to the leader that something is amiss.
- G. If only some cars have radios, then a modified set of rules apply. If only one car has a radio, operate following the no radio rules. If two or more radios are available, one radio car will be the leader and another "Tail-End Charlie." Always put non-radio cars directly behind the leader. The leader will operate using non-radio procedures with respect to the non-radio cars and will be advised by those who do have radios.

H. In all cases, the leader must be aware if there are cars in the group without overdrives. If so, the leader should put the non-overdrive cars directly behind him or her and adjust the touring speed accordingly by maintaining the gap to the non-overdrive car. The non-overdrive car driver should keep his or her speed at a comfortable rate to set the pace for the entire group.

These rules require discipline and practice. Driving a Model A requires greater focus than modern cars. So, whether you are working on your car in the garage, or enjoying a nice ride in your A-make it Safety First.





