On Thanksgiving and Christmas, food, toys and clothing are provided at their holiday distribution party at the Arboretum in Arcadia.

So, again this year we solicit your support. Bring your food donations to the November meeting. If you miss the meeting, you have a second opportunity at our annual Christmas party where you can deliver your donation directly to good old St. Nick himself.

## MAFCA Bylaw changes

The MAFCA membership recently voted approval of two MAFCA bylaw changes recommended by the MAFCA board of Directors. Garth Shreading, MAFCA President commented on these proposed changes in a previous issue of the Restorer magazine.

One by-law change increases the time a former board member must wait before he can run again after he completes his term. The time off is increased from one year to two. The purpose of the change is too provide more opportunity for others to serve on the board.

The other by-law change relates to the qualifications of car clubs petitioning MAFCA to become chapters. ## Reclining Bucket Seats for your Model A



The front seats of our Model A's were never really comfortable and if you are not a purist, this article may help you from having to listen to your spouse complain.

The distance from door to door at the rear of the front seat is 47" and at the front of the seat it is 42". This limits you to individual seats that are not over 21" wide. Find seats with projecting steel feet that can be bent to be horizontal. Seats from a Mazda Protege' will work very well.

The sub frame for these seats can be made of clear 2 x 4's (1.5" x 3.5" cut down to 1.5" x 2.5"). Use vertical bolts to go through the 2.5" height, down to meet the existing tapped holes in you car. Mount the seats on this rectangular frame by drilling all the way through the 2.5" dimension. Countersink T-nuts on the bottom and bolt from the top. Do not use lag screws.

This arrangement now gives you a nice space under your seats for storing a lug wrench, jack, fire extinguisher and tools.



## FROM THE SHOP BENCH by Bob Travis



The following article is a reprint from the July 2012 issue of Hemmings Motor News. It provides some interesting insight into choosing an effective fire extinguisher for your vehicle.

## Fire Extinguishers

There's more to protecting your classic than a trip to the hardware store.

When car enthusiasts seek fire protection, they tend to head to the nearest home store and buy a household, hand-held fire extinguisher, and then figure the situation is covered. The subject of fire suppression is actually fairly vast, but we'll touch on the basics as they apply to automobiles.

The aforementioned household extinguishers found at retail distributors are generally of the dry chemical type; this is the standard for fire suppression in the U.S., found in most residential and commercial dwellings. These units still provide a very effective means of putting out relatively small fires, and they work by essentially smothering the flames, physically cutting off the air required for combustion. Unfortunately, the chemicals used to make up the powder in these types of extinguishers are highly caustic, which means that they will have a negative impact on everything they come into contact with. In an automobile, that means that metals will be corroded, glass will be etched, and even "soft" materials like rubber and plastic can be affected. Most automotive repair experts will tell you that anything exposed to dry chemicals from a fire extinguisher will have to be replaced.

A less damaging alternative favored in the transportation industry for years is Halon. which is considered a clean agent gas. It works by displacing oxygen from the atmosphere so that combustion cannot continue. The version most commonly used today is Halon 1211, and though it is safe and effective, it also contains CFCs. and so has been banned from production worldwide. However, the product is still legal for use in the U.S. and is still available, at least until stockpiles run out. There are other clean agent gas extinguisher products available today that are

environmentally friendly, though so far, none is as effective as Halon.

Yet another option for supplemental fire suppression is foam, which has actually been used in various forms since the early part of the 20th century. Most people are familiar with fire-fighting foam for its use in the aviation industry. Currently, one of the most commonly used versions is aqueous film-forming foam (AFFF), which was developed by the U.S. Navy in the 1960s. This is a water-based product that spreads over hydrocarbon-based liquid fuels quickly providing a layer of water underneath the foam that cools the fuel to stop the formation of vapors, which suppress combustion. Because of its ability to stick to to the surface, it is sprayed on. AFFF is particularly effective at suppressing fire in moving vehicles. Although foam may appear to make a huge mess when deployed, AFFF is actually non-toxic and non-corrosive and after doing its job, the residual is simply hosed off and washed down a drain.

Like dry chemical systems. Halon and foam are also available in handheld containers, though they are more difficult to source. We recently discovered Fire Fight (www.firefightproclucts.com), (321-299-5707), a company that specializes in various supplemental fire suppression systems, offering multiple options for automotive applications, including Halon and AFFF in conventional coin-pact extinguisher containers that can be mounted in a vehicle. Fire Fight also offers an interesting alternative in the form of "passive auto deploy" fire-suppression systems that couple a heat-sensitive trigger to a compact suppressant container; when the trigger sensor experiences a pre-determined temperature, the suppressant is expelled automatically even if you're not there.
